## SITE REVIEW AND DOCUMENTATION SAMPLING

### Site Review

PREA Standard 115.401 (h) states, "The auditor shall have access to, and shall observe, all areas of the audited facilities." There have been no documented incidents of falling below the standards ratio. The population at the time of the audit was two (2) residents with one resident released shortly after the auditor's arrival. The average daily population was two (2) residents over the past year. During the tour the auditor witnessed that staffing ratios were complied with, and adequate staff were on post throughout the facility. The facility does not search or physically examine a transgender or intersex resident for the sole purpose of determining the resident's genital status. If the resident's genital status is unknown, it is determined during conversations with the resident, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. In addition, WCJD has a Memorandum of Understanding (MOU) with a local crisis center for sexual assault response. If a youth, through the screening process, is determined to be susceptible to victimization or perpetration of sexual abuse, this is shared with staff only to the extent necessary to provide for the well-being of youth. The Ward County JDC has an appropriate screening process. The auditor recommended some minor modifications to the screening tool, and they were immediately adopted, and the screening tool updated prior to the auditor leaving the on-site portion of the audit. Those views are given serious consideration, and this was demonstrated through the interviews of staff. All youth shower separately at the facility. The facility does not place lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed, or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive. The facility indicates through interviews that they will consider on a case-by-case basis assignment to a living unit that will ensure the resident's health and safety, and whether the placement would present management or security problems. Facility procedure is to manage a resident's room placement rather than using isolation as a means for protecting the resident's safety.</p>

The Ward County Juvenile Detention Center provides multiple internal ways for residents to privately report sexual abuse and sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. At the time of the on-site portion of the audit the Ward County Juvenile Detention Center was utilizing the Domestic Violence Crisis Center (DVCC) as its external reporting entity. The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 351(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The auditor discussed different options that they should pursue to find an alternate external reporting agency for residents. They immediately pursued using the Minot Police Department as their external reporting mechanism.</p> <p data-bbox="240 831 1485 1088">When the auditor performed a test call it required a resident Personal Identification Number (PIN). The Ward County Juvenile Detention Center needs to ensure that the calls to the Minot Police Department do not require a PIN to call and that calls to this number can remain confidential to protect the anonymity of the resident if requested. The facility immediately contacted their phone service provider to correct this and changed so that calls to the DVCC use a generic PIN of 7777 so that the call is not recorded, not logged on their system in conjunction with a specific resident, and thus allowing the resident to remain anonymous. They will require the same phone setup once the details are worked out for switching reporting to the Minot Police Department. The auditor performed a successful test call to the DVCC using the 7777 PIN within a housing unit to verify its operation as described. Residents have regular contact with their family and confidential access to their attorney.</p> <p data-bbox="240 1122 1485 1648"><b>CORRECTIVE ACTION:</b> At the time of the onsite portion of the audit the facility reported to the local rape crisis center. The Department of Justice put out an interpretation of standard 115.351 (b) on February 6, 2020, that states that an advocacy agency should not be used as a reporting entity. The auditor required that the posters, the handbook, the website and any other material the facility may have, be updated to remove any reference to the Domestic Violence Crisis Center as a reporting entity. The material should explicitly state that the Domestic Violence Crisis Center is to provide emotional support and advocacy services to victims of sexual abuse and that the Minot Police Department is the external entity that can be used to report sexual abuse or sexual harassment allowing the resident to remain anonymous upon request. Also, the auditor required that the system is changed so that a PIN is not required to dial this specific telephone number. Prior to the auditor leaving, the Lieutenant had changed the phone system and the posters so that youth can use the generic pin 7777. On June 13, 2022, the PREA Coordinator provided their agreement with the Minot Police Department to receive calls from residents at the Ward County Juvenile Detention Center. The Minot Police Department's Central Dispatch will immediately forward any reports of sexual abuse or sexual harassment to the Ward County Juvenile Detention Center Administrator and allow the resident to remain anonymous upon request. The Minot Police Department has agreed to have their number posted and the Ward County Juvenile Detention Center has updated their educational material to include resident training, posters, and the handbook with this new procedure. In addition, residents can call externally to the Child Abuse and Neglect Hotline number provided by the North Dakota Department of Human Services. This number is also posted on posters in the facility.</p>

Staff and youth interviews confirmed their knowledge of how the grievance process can be used to report sexual abuse and sexual harassment.</p>
