	<p data-bbox="229 192 1509 255"><b>Auditor Discussion</b></p> <p data-bbox="229 255 1509 680">The Ward County Detention Center 2.09 PREA policy not only follows the guidelines of the PREA standards but includes each PREA standard and then specifically states how the jail will meet that standard. The jail is managed by the Detention Commander who works very closely with the Captain/Assistant Detention Commander and the Lieutenant/PREA Coordinator. The Lieutenant has been assigned the role as PREA Coordinator and is a senior-level staff and directly oversees the jail's PREA efforts. These top three level staff have the time and the authority to carry out their duties. They work as a team to ensure the facility prevents, detects, and responds to sexual abuse and sexual harassment within the jail. Their files are extremely organized which made for a smooth review of documentation. They meticulously scrutinize all requirements to ensure that standards are met. They take seriously and to heart their duties for compliance and very much want a positive, safe culture at their jail. When the auditor informed them of the two standards that appeared to be out of compliance, the team was disheartened, but set out to immediately correct these discrepancies. Throughout the audit process the team was extremely responsive. For these reasons the auditor feels that this facility substantially exceeds the requirements of this standard.</p>

	<p data-bbox="231 190 1508 257"><b>Auditor Discussion</b></p> <p data-bbox="231 257 1508 683">The auditor reviewed the Ward County Detention Center's PREA policy, organization chart, verified the staffing levels through the staffing plan, the schedule that was provided and verified through direct observation while on the facility tour. The exceptionally well written staffing plan is assessed annually, and the updated staffing plan was provided to the auditor. The staffing plan was reviewed in November for the upcoming year. The results of the meeting were used to create the updated staffing plan for 2022. The updated staffing plan is signed by the Sheriff, the Chief Deputy, the Detention Commander, the Assistant Detention Commander, and the PREA Coordinator that acknowledges their meeting to discuss PREA, monitoring technology, the staffing plan, and prevention planning. The Ward County Detention Center has strong, consistent leadership, a good training program, and a positive culture. The Administrators come into the jail unannounced several times in a month, and this was verified by the log report pulled on the activity code "Unannounced Rounds" and through interviews with staff. The rounds included varying times of day to include both shifts and varying days of the week. The PREA policy prohibits staff from alerting other staff members that these supervisory rounds are occurring unless such announcement is related to the legitimate operational functions of the facility.</p>

	The Ward County Detention Center does not house youthful inmates.

<b>115.15</b>	<b>Limits to cross-gender viewing and searches</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="229 192 1509 255"><b>Auditor Discussion</b></p> <p data-bbox="229 255 1509 714">The Ward County Detention Center prohibits cross-gender searches of inmates. All staff are certified corrections officers and have been through the Correctional Officer Basic School in which cross-gender search training was taught, and they were able to demonstrate the correct search techniques to the auditor. In addition, search standards are outlined during new employee orientation in Training Requirement #10. There are female staff available to conduct searches of new female admissions in booking. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex inmates. If the offender's genital status is unknown, it is determined during conversations with the offender, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. The facility does not conduct cross gender strip or pat down searches, but policy requires that if this is to occur to document it with justification. The facility has policies and procedures and physical construction of housing areas that enable offenders to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing them in a state of undress. Shower areas are single use with a door or a curtain. Toilets within cells are digitally blacked out so they cannot be seen when viewed on the monitors.</p>

	<p>Ward County Detention Center uses the Telelanguage for interpretive services for inmates who do not speak English or when a sign language interpreter is needed. The information to access this service is prominently displayed at the booking desk. The staff will assist visually impaired or those with intellectually impairments by verbally going over the material or providing assistance in a manner they are able comprehend.</p>

The Ward County Detention Center asks the required questions within their hiring process regarding any previous sexual misconduct and documents this on a form that is signed and dated by each employee. This form also requires that the employee acknowledges understanding of the required continuing duty to report any adverse contact with law enforcement or sexual misconduct throughout the terms of their employment. These questions are asked again annually of each employee The facility does check with all previous institutional employers specifically regarding substantiated allegations of sexual abuse and provided documented evidence to support this. The auditor verified these requirements were be met by interviewing staff and viewing a sample of the required documentation.</p>

<b>115.18</b>	<b>Upgrades to facilities and technologies</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The auditor reviewed the Ward County Detention Center policy, video monitoring systems, directly observed the facility and conducted interviews with the Sheriff, the jail administrator and the PREA Coordinator. The facility considers protection of inmates and the standards when contemplating upgrades to the facility or in the application of technology. Best practice is to alleviate any area where an inmate can be in a one-on-one situation with another inmate or with a staff member. Cameras cover all areas. Storerooms and restrooms do not have cameras, but cameras cover the entrance to these rooms and all staff are aware that inmates are not allowed into these areas and that staff are never to be in an area one-on-one with inmate in areas without a camera. The camera systems are upgraded as needed throughout service. The doors to the library were removed and cameras added for better visibility while inmates are in this area.</p>

	<b>Auditor Discussion</b>
	<p>The auditor reviewed the PREA policy and interviewed both the criminal and administrative investigators that conduct investigations and the nurse. Inmates who have been sexually assaulted can be transported the Emergency Room at Trinity Hospital where the SANE will conduct a forensic sexual assault examination. The Domestic Violence Crisis Center (DVCC) provides advocacy services and there is a Memorandum of Understanding with this agency. When law enforcement responds to a sexual assault case within the jail, evidence protocol is followed, and they work cooperatively with the SANE to ensure all usable physical evidence is gathered.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1497 495">The facility refers all allegations for investigation. The Ward County Detention Center investigations are completed by qualified investigators and required documentation and reporting will occur. There are trained administrative investigators from the facility and criminal investigators from the sheriff's department available to investigate allegations of sexual misconduct within the jail. The investigators have completed the North Dakota Department of Corrections and Rehabilitation's course PREA Investigator Training. Staff sexual misconduct is investigated through an independent investigation conducted by the North Dakota Bureau of Criminal Investigations, and this is clearly outlined in policy. 	<p data-bbox="229 192 1509 255"><b>Auditor Discussion</b></p> <p data-bbox="229 255 1509 515">The auditor interviewed the PREA Coordinator, staff and reviewed training documentation. Newly hired staff have orientation training which includes the ten required components of this PREA training standard, the videos "What You Need to Know" and "Complying with PREA for the CO", sign an acknowledgement form that they understand the requirements of PREA, the facility's zero tolerance policy and that they must immediately report any information or knowledge of sexual abuse or sexual harassment. They also have in-service training and policy review where they review basic PREA information with jail staff. Staff were knowledgeable in the required competencies such as the correct first responder response – separate, provide care, protect evidence, call for assistance, notify the PREA Coordinator and provide a written report.</p>

	<b>Auditor Discussion</b>
	<p>The Ward County Detention Center trains all volunteers and contractors at the level of their interaction with inmates. Training was verified through the interview process with staff, contractors, and volunteers and through review of training records with signature sheets. Through COVID-19 there were limited volunteers utilized by the facility. They anticipate a re-training prior opening back up fully to volunteer service again.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="231 190 1508 257"><b>Auditor Discussion</b></p> <p data-bbox="231 257 1508 616">The Ward County Detention Center provides basic information to an inmate during the intake process about the jail's zero tolerance policy and how to report. The information is presented to the inmate in a PREA handout during the booking process that the inmate signs for. The pamphlet is also in the handbook. The handbook can be requested in hardcopy and is available electronically on the kiosk. The jail staff review this information orally with inmates with low literacy or comprehension levels or other disabilities or issues that may prevent them from learning this information on their own. The PREA Coordinator shows a video and trains all inmates within thirty days of intake on more comprehensive PREA information. PREA information is readily available on posters and on the kiosk in the housing area throughout the inmate's stay. In addition, the PREA Coordinator completes a monthly walk-through in which she visits every housing area and ensures all inmates understand the multiple ways to report. The auditor verified compliance with this standard through staff and inmate interviews and by reviewing a sample of for the initial and secondary, more comprehensive training for inmates.</p>



<b>115.34</b>	<b>Specialized training: Investigations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="231 197 1508 257"><b>Auditor Discussion</b></p> <p data-bbox="231 257 1508 515">The investigators for the Ward County Detention Center have received specialized training as facility investigators through the North Dakota Department of Corrections and Rehabilitation's course "PREA Investigator Training". The auditor interviewed both the administrative and criminal investigators. Specialized training included techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. The investigators provided the auditor with documentation of the training they completed. Allegations of staff criminal sexual misconduct are referred to the North Dakota Bureau of Investigations.</p>

115.35	<b>Specialized training: Medical and mental health care</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1485 600">The health staff are contracted through Trinity Hospital. They have completed the specialized training through the National Institute of Corrections "PREA Medical Health Care for Sexual Assault Victims in Confinement". The Nurse Practitioner (NP) was certified as a SANE when working previously as a Registered Nurse. They do not conduct forensic exams at this facility, but it was apparent during the NP interview that her experience has definitely provided her quite a bit of specialized knowledge in how to detect and assess signs of sexual abuse and sexual harassment; how to preserve physical evidence of sexual abuse; how to respond effectively and professionally to victims of sexual abuse and sexual harassment; and how and to whom to report allegations or suspicions of sexual abuse and sexual harassment. All inmates who would report a sexual assault are transported to the local hospital with SANE services. There is a posted notice within medical spaces that discloses staff must report any incidents of sexual abuse or sexual harassment that occurred within a facility. They would obtain informed consent prior to reporting incident about prior sexual victimization that did not occur in an institutional setting.</p>

115.41	<b>Screening for risk of victimization and abusiveness</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1485 432">The auditor spoke with the PREA Coordinator, staff and reviewed inmate screening documents. The Ward County Detention Center completes a screening process upon intake. Staff confirmed that they are continually reassessing an inmate's status. The auditor found no documented evidence of reassessment inmates within 30 days of the initial booking. Prior to the auditor leaving site, the PREA Coordinator had developed a new method of ensuring the rescreening was done in conjunction with the more comprehensive education session so that both were sure to be completed within 30 days of intake.</p> <p data-bbox="244 465 1485 725"><b>CORRECTIVE ACTION:</b> To be compliant with this standard, the auditor required WCDC to reassess the inmate's risk of victimization or abusiveness within 30 days of the inmate's arrival. As verification, the auditor required documentation of a dated reassessment of a sample of current inmates within the Ward County Detention Center. The new procedure is that when the PREA Coordinator presents the more comprehensive education to the inmates when she has them sign their education sheet, she also asks if they have any change of information from their initial screening. This is documented on the education/rescreening form. She also ensures the facility has received no new information that would change the inmate's classification as to the potential to be a victim or perpetrator such as recent allegations, and then signs the form as well. On May 23, 2022, the PREA Coordinator provided the samples as requested.</p>

<b>115.42</b>	<b>Use of screening information</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<p data-bbox="244 210 453 237"><b>Auditor Discussion</b></p> <p data-bbox="244 271 1493 533">The Ward County Detention Center screening process is used along with other classification methods to determine placement within their housing areas. There are enough housing options that if they had more inmates, they could keep them separate if the screening indicated this was necessary. All inmates shower separately from other offenders. The jail considers the concerns of a transgendered or intersex inmate's own view with respect to his or her own safety. Those views are given serious consideration, and this was demonstrated through the interviews of staff and inmates. The facility does not place lesbian, gay, bisexual, transgender, or intersex inmates in particular housing, bed or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive.</p>

The Ward County Detention Center provides multiple internal ways for inmates to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. At the time of the on-site portion of the audit the Ward County Detention Center was utilizing the Domestic Violence Crisis Center (DVCC) as its external reporting entity. The auditor informed the facility that the Department of Justice legal interpretation of this standard through a FAQ posted on the PREA Resource Center website dated 6Feb2020 states that typically a rape crisis center and other victim service providers should not be used for this purpose. They have a mission of providing support and services to victims. Under federal law, if such centers and providers are funded at least in part, either as a direct recipient or as a subrecipient of certain federal grants they are required to keep identifying information about victims confidential. The only limited exceptions to this requirement are when the victim signs an informed, written, time-limited release, or when release is required by a legal mandate. This requirement to keep confidential identifying information about victim's conflicts with the requirement of PREA Standard 51(b) to be able to immediately forward reports of sexual abuse and sexual harassment to agency officials. The auditor discussed different options that they should pursue to find an alternate external reporting agency for inmates. They immediately pursued using the Minot Police Department as their external reporting mechanism. When the auditor performed a test call it required an inmate Personal Identification Number (PIN). The Ward County Detention Center needs to ensure that the calls to the Minot Police Department do not require an inmate PIN to call and that calls to this number can remain confidential to protect the anonymity of the inmate if requested. The facility immediately contacted their phone service provider to correct this and changed so that calls to the DVCC use a generic PIN of 7777 so that the call is not recorded, not logged on their system in conjunction with a specific inmate, and thus allowing the inmate to remain anonymous. They will require the same phone setup once the details are worked out for switching reporting to the Minot Police Department. The auditor performed a successful test call to the DVCC using the 7777 PIN within a housing unit to verify its operation as described.</p> <p data-bbox="240 1099 1485 1357"><b>CORRECTIVE ACTION:</b> The auditor required an alternate method for inmates to report sexual abuse and sexual harassment to an external entity. The facility immediately pursued an alternate reporting mechanism and entered into an agreement with the Minot Police Department. On June 13, 2022, the PREA Coordinator provided their agreement with the Minot Police Department to receive calls from inmates at the Ward County Detention Center. The Minot Police Department's Central Dispatch will immediately forward any reports of sexual abuse or sexual harassment to the Ward County Detention Center Jail Administrator or PREA Coordinator and allow the inmate to remain anonymous upon request. The Minot Police Department has agreed to have their number posted and the Ward County Detention Center has updated their educational material to include inmate training, posters, handbook and the kiosk with this new procedure.</p>

	<p data-bbox="242 210 451 235"><b>Auditor Discussion</b></p> <p data-bbox="242 271 1484 831">The auditor reviewed the PREA policy 2.09 regarding Inmate Grievances, and conducted staff and inmate interviews. Inmates can submit paper grievance forms or electronic grievances through the kiosk system. The Ward County Detention Center does not impose a time limit on when an offender may submit a grievance regarding an allegation of sexual abuse. They do not require an offender to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse. They ensure that an offender who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint. They issue a final decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance. Third parties, including fellow offenders, staff members, family members, attorneys, and outside advocates, are permitted to assist offenders in filing requests for grievances relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of offenders. They have established procedures for the filing of an emergency grievance when the offender is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the Ward County Detention Center immediately forwards the grievance to the Jail Commander or the Sheriff's Office for immediate corrective action and provides an initial response within 48 hours and issues a final decision within 5 calendar days. The initial response and final decision documents their determination whether the offender is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. The Ward County Detention Center may discipline an offender for filing a grievance related to alleged sexual abuse only where the Ward County Detention Center demonstrates that the offender filed the grievance in bad faith.</p>

	<p>Inmates have access to outside confidential support services. As required by standard 115.53, the WCDC must inform inmates, prior to giving them access to confidential support services, of the extent to which such communications will be monitored and the extent to which reports of abuse will be forwarded to authorities in accordance with mandatory reporting laws.</p>

All written reports are retained for as long as the alleged abuser is incarcerated or employed by the facility plus five years. Investigations will not be terminated due to the departure of an alleged abuser or victim. These steps are properly documented in the PREA policy. The investigators have completed specialized training. The investigations include efforts to determine whether staff actions/failures contributed to the abuse documented through written reports, which will include physical/testimonial evidence, credibility assessments and investigative facts and findings.</p>
